As described in the issuer's registration statement on Form S-1 (File No. 333-253370) under the heading "Description of Securities-Founder Shares," the Class B ordinary shares, par value \$0.0001 per share, of the issuer will automatically convert into Class A ordinary shares, par value \$0.0001 per share, of the issuer at the time of the issuer's initial business combination, or earlier at the option of the holder, on a one-for-one basis, subject to certain adjustment, and have no expiration date.

2. Waldencast Long-Term Capital LLC (the "Sponsor") is the record holder of the securities reported herein. The Sponsor is directly controlled by Waldencast Ventures, LP, Burwell Mountain Trust, controlled by Michel Brousset and Felipe Dutra, respectively, and Dynamo Master Fund. Dynamo Internacional Gestao de Recursos Ltda., a Brazilian limited company, is the investment manager of Dynamo Master Fund. Each of Michel Brousset, Waldencast Ventures, LP, Felipe Dutra, Burwell Mountain Trust, Dynamo Master Fund and Dynamo Internacional Gestao de Recursos Ltda. may be deemed to beneficially own the issuer's shares held by the Sponsor by virtue of their direct and indirect ownership, respectively, over the Sponsor. Michel Brousset, Waldencast Ventures, LP, Felipe Dutra, Burwell Mountain Trust, Dynamo Internacional Gestao de Recursos Ltda. disclaim any beneficial ownership of the Class B ordinary shares held by the Sponsor, except to the extent of their respective pecuniary interest therein, if any.
